**The Agenda** was adopted by motion made by Ken Bagshaw, seconded by Frank Godfrey.

Executive Director's Report – A co-op student from St. Mary's High School will start next week. The art classes are starting. Two grants have been applied for. 60 people attended the artist's talk for the current exhibition. The fourth and final Spotlight event is set for Thursday February 21<sup>st</sup> at 7 pm.
